had come under fire over questionable security. The story highlights the tension between private data and public safety in the aftermath of Edward Snowden's revelations about the extent of government surveillance. In June, following reports that the National Security Agency had hacked into the Android operating system of more than a dozen major phone companies, Google's head of cybersecurity policy gave a talk at the Aspen Security Forum in which he outlined how his company would work to improve Android's privacy. The company has since announced that it's collaborating with several phone companies on a new version of Android that includes much tighter protections for device users. It's also created a new "Incident Response" team that will respond to government requests for information on the location and identity of a device's owner. And Google has just announced that it will build a custom version of Android for government agencies to use.
